A PROCLAMATION.

CARLISLE.

THEREAS by a Proclamation of the Lord Lieutenant and Council of Ireland, bearing date the Eleventh day of December, 1841, in pursuance of the provisions of the Statutes therein particularly set forth and mentioned, the County of Mavo was divided into the Districts or Divisions therein mentioned, for Sessional purposes, one of said Divisions to be called the District or Division of Ballina, and was appointed to consist of the Baronies of Erris and Tirawlev (save and except so much of said Barony of Tirawley as was comprised in the Parish of Addergoole), the Barony of Gallen, and so much of the Barony of Costelloe as was comprised in the Parishes of Aghamore, Kilmovee, Kilcolman, Castlemore, and Kilbeagh; and it was by said Proclamation amongst other things directed that the Towns of Ballina, Swineford, and Belmullet, should be the Towns for holding Sessions in and for said District of Ballina; and that a General Sessions of the Peace and Civil Bill Court, for transacting all such Criminal and all such other Business as might be cognizable or determinable at any General or Quarter Sessions of the Peace, should be held Twice in each and every Year in the said Town of Ballina, in and for the said District; that a General Sessions of the Peace and Civil Bill Court, for the purposes aforesaid, should be held in the Town of Swineford Twice in each and every Year in and for the said District; and that One General Sessions of the Peace and Civil Bill Court, for the purposes aforesaid, should be held in each and every Year in the said Town of Belmullet, in and for said District.

And whereas by an Act passed in a Session of Parliament, held in the Fourteenth and Fifteenth Years of the Reign of Her present Majesty, entitled "An Act to consolidate and amend the Laws relating to Civil Bills, and the Courts of Quarter Sessions in Ireland, and to transfer to the Assistant Barristers certain Jurisdiction as to Insolvent Debtors," power and authority is given to the Lord Lieutenant or other Chief Governor or Governors of Ireland for the time being, by and with the advice of the Privy Council, to alter the Divisions and Districts for the holding of Sessions

for the purpose of more conveniently hearing and determining Causes by Civil Bills, and of transacting all such Criminal or all such other Business as may be cognizable or determinable at any General or Quarter Sessions of the Peace, and to appoint one or more convenient Town or Place, Towns or Places, in any such Division or District in which a Civil Bill Court and a Court for transacting such Criminal and other Business as aforesaid, shall be held. And whereas a Memorial hath been presented to Us by certain Magistrates and other Persons, inhabitants of the Town of Ballina and its vicinity, praying that the said District or Division of Ballina might be altered. And whereas We deem it expedient to alter the said District or Division of Ballina: Now We, the Lord Lieutenant of Ireland, in pursuance of the Powers vested in Us for that purpose, under and by virtue of the said recited Act, and all other Acts and Powers Us thereunto enabling, by and with the advice of Her Majesty's Privy Council in Ireland, Do hereby declare and direct that, from and after the October Sessions for the present Year of our Lord 1860, to be holden in. and for the District or Division of Ballina, in said County of Mayo, the said District or Division of Ballina, in the said County, as appointed under the said Proclamation of Eleventh day of December, 1841, shall stand and be annulled; and that, from and after the said October Sessions in the said Year 1860, the said District or Division of Ballina shall be divided into the Districts or Divisions following, that is to say: -One of said Divisions to be called the District or Division of Ballina, and to consist of the Barony or Half-Barony of Erris, the Barony of Tirawley (save and except so much of said Barony of Tirawley as is comprised in the Parish of Addergoole), and so much of the Barony of Gallen as is comprised in the Parishes of Attymas and Kilgarvan, in said Barony of Gallen: and We nominate and direct

that the Towns of Ballina and Belmullet be the Towns for holding Sessions in and for the said District of Ballina: and that a General Sessions of the Peace and Civil Bill Court, for transacting all such Criminal and all such other Business as

in any County now existing, and to divide any Division of a County into as many Divisions or Districts as shall be thought proper or expedient,

may be cognizable or determinable at any General or Quarter Sessions of the Peace, to be held Four times in each and every Year in the Town of Ballina, in and for the said District of Ballina; and that One General Sessions of the Peace and Civil Bill Court, for the purposes aforesaid, shall be held in each and every Year in the Town of Belmullet, in and for the said District of Ballina; that the other of said Divisions be called the Distriet or Division of Swineford, and shall consist of the remainder of the Barony of Gallen, which said remainder comprises the Parishes of Bohola, Kilconduff, part of Kildacommoge, Killasser, Killedan, Meelick, Templemore, and Toomore, and so much of the Barony of Costelloe as is comprised in the Parishes of Aghamore, Kilmovee, Kilcolman, Kilturra, Castlemore, and Kilbeagh, respectively, within the said Barony of Costelloe. And We nominate and direct that the Town of Swineford be the Town for holding Sessions in and for the said District of Swineford; and that a General Sessions of the Peace and Civil Bill Court for transacting all such Criminal and all such other Business as may be cognizable or determinable at any General or Quarter Sessions of the Peace, be held Four times in each and every Year in the said Town of Swineford, in and for the said District of Swineford.
