## A PROCLAMATION.

### CARLISLE.

**W**HEREAS the County of Clare has been and now is divided into Four Divisions or Districts, for the holding of General or Quarter Sessions of the Peace for hearing and determining Causes by Civil Bill, and all such Criminal and other business as may be cognizable or determinable at any General or Quarter Sessions of the Peace.

And whereas by a Proclamation of the Lord Lieutenant and Council, bearing date the Second day of January, One Thousand Eight Hundred and Forty-one, two of the said Divisions or Districts, namely, Ennistymon and Ennis, were declared to consist of the portions of said County of Clare, in the said Proclamation particularly mentioned; and the Town of Ennistymon was, by said Proclamation, appointed to be the Town for holding Sessions in and for said District of Ennistymon; and that Sessions should be held therein four times in each and every year, in and for said District of Ennistymon. And by the said Proclamation the Towns of Ennis and Six-Mile-Bridge were the Towns appointed for holding Sessions in and for said District of Ennis; and that Sessions should be held therein twice in each and every year, in each of the said Towns of Ennis and Six-Mile-Bridge, in and for said District of Ennis.

And whereas by a further Proclamation, bearing date the Twenty-ninth day of December, One Thousand Eight Hundred and Forty-two, the Lord Lieutenant and Council of Ireland did appoint and direct, that from and after the Hilary Sessions of the Year One Thousand Eight Hundred and Forty-three, so much of the foregoing stated Proclamation as relates to the appointment of the number of Sessions to be annually holden in the said Towns of Ennis and Six-Mile-Bridge, should be annulled; and that from and after said Hilary Sessions, for the Year One Thousand Eight Hundred and Forty-three, the said General Sessions should be holden three times in every year, in the said Town of Ennis, in and for said District of Ennis; and that one General Sessions should be holden in every year in the said Town of Six-Mile-Bridge, in and for the said District of Ennis; and that the said Proclamation, dated Second day of Ja-

nuary, One Thousand Eight Hundred and Forty-one, should in all other respects stand confirmed.

And whereas by an Act passed in a Session of Parliament held in the Fourteenth and Fifteenth Years of the Reign of Her present Majesty, Chapter Fifty-seven, entitled "An Act to consolidate and amend the Laws relating to Civil Bills and the Courts of Quarter Sessions in Ireland, and to transfer to the Assistant-Barrister certain Jurisdiction as to Insolvent Debtors," powers are given to the Lord Lieutenant, by and with the consent and advice of the Privy Council, to alter existing Divisions, and appoint one or more Town or Towns for holding such General Sessions as aforesaid, and to discontinue the holding of Sessions in any Town when deemed expedient; and also to direct that a General Session of the Peace and Civil Bill Court should be held any number of times, not exceeding four times, in every year, in all or any of the Towns or Places then appointed, or which might thereafter be appointed for holding Sessions.

And whereas by a Proclamation dated the Ninth February, One Thousand Eight Hundred and Forty-two, it was ordered that certain detached portions of the Barony of Upper Tullagh, comprising the Townlands therein mentioned, belonging to the Parish of Kilfeenaghta, should be annexed to and incorporated with the Barony of Lower Bunratty, since which time no part of the said Parish of Kilfeenaghta is situated within the Barony of Tullagh aforesaid.

And whereas Memorials have been presented unto Us by certain Inhabitants of the said County of Clare, praying for a Reduction of the Number of Sessions, and that arrangements should be made with respect to the Criminal Business thereof which might lead to the convenience of the Jurors; and it appearing unto Us, that it would be fit and expedient that the said Two Districts of Ennistymon and Ennis should be formed into One District, to be called the District of Ennis and Ennistymon; that the Towns of Ennistymon and Ennis be the Quarter Sessions Towns for such District; that the holding of Sessions in the Town of Six Mile-Bridge be discontinued; that a General Session of the Peace and Civil Bill Court should be held twice in each and every year in said Town of Ennistymon (instead of four times as at present); and that a General Session of the Peace and Civil Bill Court should be held four times in each and

every year in said Town of Ennis (in lieu of the three Sessions now held there, and of the one Session now held at Six-Mile-Bridge.)

Now We, the Lord Lieutenant of Ireland, in pursuance of the powers vested in Us for that purpose, under and by virtue of the said recited Act, and all other Acts and powers, Us thereunto enabling, by and with the consent and advice of Her Majesty's Privy Council in Ireland, do hereby declare and direct that from and after the October Sessions for the present Year of our Lord One Thousand Eight Hundred and Sixty, the holding of Sessions in the said Town of Six-Mile-Bridge be discontinued, and that each of the said Districts or Divisions of Ennistymon and Ennis, as they were respectively appointed in manner hereinbefore mentioned, be, and the same are hereby annulled as separate and distinct Districts or Divisions; and that the same shall form and be One District or Division, to be called the District or Division of Ennis and Ennistymon as hereinafter mentioned.

And We do hereby order and direct that from and after the said October Sessions, One Thousand Eight Hundred and Sixty, the said new District or Division of Ennis and Ennistymon shall consist of the Baronies of Burren, Corcomroe, Inchiquin, Islands, Upper Bunratty, and Lower Bunratty, and the Parish of Kilmalboy, being part of the Barony of Ibrickan, all being situate in the County of Clare aforesaid.

And We nominate and direct that the Towns of Ennistymon and Ennis be the Towns for holding Sessions in and for the said District or Division of Ennis and Ennistymon; and that a General Sessions of the Peace and Civil Bill Court for transacting all such Criminal and all such other business as may be cognizable or determinable at any General or Quarter Sessions of the Peace be held twice in each and every year in said Town of Ennistymon, in and for the said new District or Division of Ennis and Ennistymon; and that a General Sessions of the Peace and Civil Bill Court for transacting all such Criminal and all such other business as may be cognizable or determinable at any General or Quarter Sessions of the Peace be held four times in each and every year in the said Town of Ennis, in and for the said new District or Division of Ennis and Ennistymon.
