

**WATERFORD DISTRICT—CLOSE  
SEASON.  
FISHERIES.**

**WE**, the Commissioners acting in execution of an Act made and passed in the Session of Parliament held in the fifth and sixth years of the reign of Her present Majesty, intituled "An Act to regulate the Irish Fisheries," and the several Acts since passed amending the same, (having taken the necessary preliminary steps for the purpose,) in pursuance of the powers and authorities in us vested in that behalf, do hereby decide, that in the District No. 3, heretofore defined and known as the Waterford District, situated in the Counties of Waterford, Wexford, Kilkenny, Tipperary, and the King's and Queen's Counties, the respective periods authorized and directed as the Close Time for Salmon or Fish of the Salmon kind and Trout, shall cease.

And We, the said Commissioners, do hereby further decide, that the Close Time, during which it shall not be lawful to kill, destroy, or take Fish of the Salmon kind in or from any Estuary, or on the Sea Coast, or in or from the Tideway of any River or Lake, or the part thereof where the tide ebbs and flows, or in or from any part of any River or Lake above the Tideway, within the limits of

the said Waterford District, (except that part of the said District known as the Electoral Division A hereinafter mentioned,) with Nets and all other Engines (save Rods and Lines only), shall be between the 15th day of September in each year, and the 1st day of March in the year following.

And We, the said Commissioners, do hereby further decide, that in the Electoral Division of said District, known as the said Electoral Division A, (and which Electoral Division A has been, by said Commissioners, heretofore defined as "The whole of the Sea along the Coast or Tideway between Kiln Bay and Helwick Head, and around any Islands or Rocks situate off the same, and the Estuary of the Harbour of Waterford, from its mouth to the junction of the waters of the Suir, Nore, and Barrow, to a line drawn between the points of Drowndowney, in the County of Kilkenny, and Check Point, in the County of Waterford, and from Check Point to Mount Kent, in the County of Wexford, and the whole of the Tidal portions of the several Rivers flowing into the Bay of Bannow, in the County of Wexford,") the Close Time, during which it shall not be lawful to kill, destroy, or take Salmon, Fish of the Salmon kind, or Trout, by Nets or Engines of any description, shall be between the 31st day of August, in each year, and the 12th day of February in the year following.

And We, the said Commissioners, do hereby further decide, that the Close Time, during which it shall not be lawful to kill, destroy, or take Fish of the Salmon or Trout kind in or from any part of any River or Lake, within the limits of the said Waterford District, with Rods and Lines only, shall be between the 28th day of September, in each year, and the 1st day of March in the year following.
