*ST. GERMANS.*

**WHEREAS** pursuant to the provisions of an Act passed in the sixteenth year of the reign of Her present Majesty, intituled "An Act for the more equal Distribution of the Borough of Cork into Wards, and to provide for the better Constitution and Regulation of the Municipal Corporation of the said Borough, and for other purposes," James Major, Esq., one of Her Majesty's Counsel at Law, and Francis Yarde Gilbert, Esq., Captain in the Corps of Royal Engineers, appointed by His Excellency the Lord Lieutenant, to divide the said Borough of Cork into Seven Wards, have divided the said Borough of Cork into Seven Wards, and determined and set out anew, the extent, limits, and boundary lines, and description of said Wards of said Borough, the particulars of which Divisions are as follows, that is to say :—

*No. 1, North-east Ward.*—From the centre of Saint Patrick's-bridge, northward along Bridge-street, Saint Patrick's Hill, and Audley-place, to the point at which the same meets the Old Youghal-road; thence eastward along the Old Youghal-road, to the point at which the same meets the Ordnance-road at the Military Barracks; thence northward, eastward, and northward along the said Ordnance-road to the point at which the same meets Black Miller's-lane; thence eastward along Black Miller's-lane to the point at which the same meets the Townland Boundary of Clashganniff; thence northward along the Townland Boundary of Clashganniff, to the point at which the same meets the Municipal Boundary; thence eastward and southward along the Municipal Boundary to the point at which the same meets the River Lee; thence westward along the River Lee to the point first described.

*No. 2, North-west Ward.*—From the centre of Saint Patrick's-bridge, westward along the north branch of the River Lee, to the point at which the same meets the Municipal Boundary; thence northward and eastward along the Municipal Boundary to the point at which the same meets the Townland Boundary of Clashganniff; thence

southward along the Townland Boundary of Clashganniff, to the point at which the same meets Black Miller's-lane; thence westward along Black Miller's-lane, to the point at which the same meets the Ordnance-road; thence southward, westward, and southward along the Ordnance-road, to the point at which the same meets the Old Youghal-road; thence westward along the Old Youghal-road, to the point at which the same meets Audley-place; thence southward along Audley-place, Saint Patrick's Hill, and Bridge-street, to the point first described.

*No. 3, North Centre Ward.*—From the centre of Saint Patrick's-bridge, eastward along the north branch of the River Lee, to the point at which the same meets Custom House-street; thence southward along Custom House-street, to the point at which the same meets Lower George's-street; thence westward along Lower George's-street and Mayler-street, to the point at which the same meets Saint Patrick's-street; thence westward along Saint Patrick's-street, to the point at which the same meets the Grand Parade; thence northward along the Grand Parade to the point at which the same meets Corn Market-street; thence northward along Corn Market-street, to the point at which the same meets the north branch of the River Lee; thence eastward along the north branch of the River Lee, to the point first described.

*No. 4, South Centre Ward.*—From the centre of Anglesey-bridge, westward along the south branch of the River Lee, to the point at which the same meets the Grand Parade; thence northward along the Grand Parade, to the point at which the same meets George's-street; thence eastward along George's-street and Lower George's-street, to the point at which the same meets Custom House-street; thence northward along Custom House-street, to the point at which the same meets the north branch of the River Lee; thence eastward along the north branch of the River Lee, to the point at which the same meets the south branch of the River Lee; thence westward along the south branch of the River Lee, to the point first described.

*No. 5, Centre Ward.*—From the centre of the South-bridge, northward along South Main-street and Paradise-place, to the point at which the same meets Castle-street; thence eastward along Castle-street, to the point at which the same meets the Grand Parade; thence southward along the Grand Parade, at the point at which the same meets Saint Patrick's-street; thence eastward along Saint Patrick's-street, to the point at which the same meets Mayler-street; thence eastward along Mayler-street and Warren's-place, to the

point at which the same meets George's-street; thence westward along George's-street, to the point at which the same meets the Grand Parade; thence southward along the Grand Parade, to the point where the same meets the south branch of the River Lee; thence westward along the south branch of the River Lee, to the point first described.

*No. 6, West Ward.*—From the centre of the South-bridge, westward along the south branch of the River Lee, to the point at which the same meets the Municipal Boundary; thence northward along the Municipal Boundary, to the point at which the same meets the north branch of the River Lee; thence eastward along the north branch of the River Lee, to the point at which the same meets Corn Market-street; thence southward along Corn Market-street, to the point at which the same meets Castle-street; thence westward along Castle-street, to the point at which the same meets North Main-street; thence southward along North Main-street and South Main-street, to the point first described.

*No. 7, South Ward.*—From the centre of Anglesey-bridge, eastward along the south branch of the River Lee, and the River Lee, to the point at which the same meets the Municipal Boundary; thence southward, westward, and northward along the Municipal Boundary, to the point at which the same meets the River Lee; thence eastward along the south branch of the River Lee, to the point first described.

Now We, the Lord Lieutenant, by and with the advice of Her Majesty's Privy Council, do hereby approve of the Determination and Division aforesaid.
