*ST. GERMANS.*

**W**HEREAS pursuant to the provisions of an Act passed in the sixteenth year of Her present Majesty, intituled "The Limerick Corporation Act, 1853," to amend the Acts for the Regulation of Municipal Corporations in Ireland, so far as relates to the Borough of Limerick, James Major, Esq., one of Her Majesty's Counsel at Law, and Francis Yarde Gilbert, Esq., Captain in the Royal Engineers, duly appointed Commissioners by His Excellency the Lord Lieutenant, to divide anew the Borough of Limerick into Eight Wards, and to determine and set out anew the extent, limits, and boundary lines of the said Wards of the said Borough, have divided anew the Borough of Limerick into Eight Wards, and set out anew the extent, limits, and boundary lines of the said several Wards, and the names and particulars of the said Wards are as follow, that is to say:—

*No. 1, Castle Ward.*—From the centre of Ball's-bridge, westward along the Abbey River, to the point at which the same meets the River Shannon; thence southward along the River Shannon, to the point at which the same meets the Municipal Boundary; thence northward and eastward along the Municipal Boundary, to the point at which the same meets the Boundary of the Parish of St. Minchin; thence southward and westward along the Boundary of the Parish of St. Minchin, to the point at which the same meets Nicholas-street; thence southward along Nicholas-street and Mary-street, to the point first described.

*No. 2, Abbey Ward.*—From the centre of Ball's-bridge, northward along Ball's-bridge, Mary-street, and Nicholas-street, to the point at which the same meets the Boundary of the Parish of St. Minchin; thence eastward and northward along the Boundary of the Parish of St. Minchin, to the point at which the same meets the Municipal Boundary; thence northward, eastward, southward, and westward, along the Municipal Boundary, to the point at which the same meets the South Boundary of the Townland of Killallee; thence northward along the Boundary of the Townland of Killallee, to the point at which the same meets the Boundary of the Townland of Monamuck; thence westward and northward along the Boundary of the Townland of Monamuck, to the point at which the same meets the Abbey River; thence westward along the Abbey River, to the point first described.

*No. 3, Irishtown Ward.*—All that portion of the Borough, situated within the Townland of Irishtown.

*No. 4, Custom House Ward.*—From the centre of New-bridge, eastward along the Abbey River, to the point at which the same meets the Bound-



ary of the Parish of St. John; thence southward along the Boundary of the Parish of St. John, to the point at which the same meets High-street; thence southward along High-street, to the point at which the same meets Upper Denmark-street; thence westward along Upper and Lower Denmark-street, to the point at which the same meets George's-street; thence southward along George's-street, to the point at which the same meets Bedford-row; thence westward along Bedford-row, to the point at which the same meets Henry-street; thence southward along Henry-street, to the point at which the same meets Shannon-street; thence westward along Shannon-street, to the point at which the same meets the River Shannon; thence northward along the River Shannon, to the point at which the same meets the Abbey River; thence eastward along the Abbey River, to the point first described.

*No. 5, Market Ward.*—From the point at which Lower Denmark-street meets George's-street, eastward along Lower and Upper Denmark-street, to the point at which the same meets High-street; thence northward along High-street, to the point at which the same meets the Boundary of the Parish of St. John; thence southward along the Boundary of the Parish of St. John, to the point at which the same meets the Municipal Boundary; thence southward along the Municipal Boundary, to the point at which the same meets the Waterford and Limerick Railway; thence westward along the Waterford and Limerick Railway, to the point at which the same meets the Boundary of the Parish of St. Michael; thence northward along the Boundary of the Parish of St. Michael, to the point at which the same meets Sexton-street; thence westward along Sexton-street, to the point at which the same meets Wickham-street; thence northward along Wickham-street, to the point at which the same meets Thomas-street; thence westward along Thomas-street, to the point at which the same meets George's-street; thence northward along George's-street, to the point first described.

*No. 6, Shannon Ward.*—From the point at which Shannon-street meets Henry-street, northward along Henry-street, to the point at which the same meets Bedford-row; thence eastward along Bedford-row and Thomas-street, to the point at which the same meets Wickham-street; thence southward along Wickham-street, to the point at which the same meets Sexton-street; thence eastward along Sexton-street, to the point at which the same meets the Boundary of the Parish of St. Lawrence; thence southward along the Boundary of the Parish of St. Lawrence, to the point at which the same meets the Waterford and Limerick Railway; thence westward along the Waterford and Limerick Railway, Queen-street, and Upper Glentworth-street, to the point at which the same meets Catherine-street; thence northward along Catherine-street, to the point at which the same meets Upper Cecil-street; thence westward along Upper and Lower Cecil-street, to the point at which the same meets the River Shannon; thence northward along the River Shannon, to the point at which the same meets Shannon-street; thence eastward along Shannon-street, to the point first described.

*No. 7, Glentworth Ward.*—From the point at which George's-street meets Lower Mallow-street, westward along Lower Mallow-street, to the point at which the same meets the River Shannon; thence northward along the River Shannon, to the point at which the same meets Lower Cecil-street; thence eastward along Lower and Upper Cecil-street, to the point at which the same meets Catherine-street; thence southward along Catherine-street, to the point at which the same meets Upper Glentworth-street; thence eastward along Upper Glentworth-street, Queen-street, and the Waterford and Limerick Railway, to the point at which the same meets the Municipal Boundary; thence southward and westward along the Municipal Boundary, to the point at which the same meets the Boundary of the Townland of Ballinacurra Weston; thence northward and westward along the Boundary of the Townland of Ballinacurra Weston, to the point at which the same meets Edward-street; thence northward along Edward-street, to the point at which the same meets Henry-street South; thence in a straight line westward, to the point at which the same meets Upper Hartstonge-street; thence westward along Upper Hartstonge-street, to the point at which the same meets George's-street; thence northward along George's-street, to the point first described.

*No. 8, Dock Ward.*—From the point at which George's-street meets Lower Mallow-street, westward along Lower Mallow-street, to the point at which the same meets the River Shannon; thence southward along the River Shannon, to the point at which the same meets the Municipal Boundary; thence eastward and northward along the Municipal Boundary, to the point at which the same meets the East Boundary of the Townland of Ballinacurra Weston; thence northward and westward along the Boundary of the Townland of Ballinacurra Weston, to the point at which the same meets Edward-street; thence northward along Edward-street, to the point at which the same meets Henry-street South; thence in a straight line westward, to the point at which the same meets Upper Hartstonge-street; thence westward along Upper Hartstonge-street, to the point at which the same meets George's-street; thence northward along George's-street, to the point first described.

And whereas the said Commissioners, in compliance with the provisions of the said "Limerick Corporation Act, 1853," thereby also declared that the Four Wards, the Aldermen of which should first go out of office, should be the Castle Ward, Irishtown Ward, Market Ward, and Glentworth Ward.

Now We, the Lord Lieutenant, by and with the advice of Her Majesty's Privy Council, do hereby approve of the Determination, Division, and Declaration aforesaid.
