

By the Lord Lieutenant and Privy Council of
Ireland.

CARLISLE.

WHEREAS a certain Act was passed in a Session of Parliament holden in the 17th Year of the Reign of Her Majesty Queen Victoria, Chapter 17, entitled "An Act to make further provision for defining the Boundaries of Counties, Baronies, Half-Baronies, Parishes, Townlands, and other Divisions and Denominations of Land in Ireland for public purposes;" and a certain other Act was passed in a Session of Parliament holden in the 20th and 21st Years of the Reign of Her said Majesty, Chapter 45, entitled "An Act to make further provision for defining the Boundaries of certain Denominations of Land in Ireland for public purposes;" and also a certain other Act was passed in a Session of Parliament holden in the 22nd and 23rd Years of the Reign of Her said Majesty, Chapter 8, entitled "An Act to amend the Act of the 20th and 21st Years of Victoria, Chapter 45, relating to the Survey of Boundaries in Ireland."

And whereas Sir Richard Griffith, Bart., being the "Boundary Surveyor" in that behalf duly appointed, having found that changes and alterations had taken place in the courses of certain Rivers, Streams, and Fences, which had before formed the Boundary in certain places of the County Down, and of the adjoining Counties Antrim and Armagh, and of several Baronies, Parishes, Townlands, or other Divisions or Denominations of Land in the said County of Down, and that Land had been reclaimed from the Sea, and from tidal Rivers and Lakes, he, the said Sir Richard Griffith, did ascertain, define, and mark out the present acknowledged or reputed Boundaries of such portions of the said Counties, Baronies, Parishes, Townlands, and other Divisions or Denominations of Land, as he deemed it necessary to ascertain, define, or mark out, the particulars whereof respectively are stated and described in a certain Report and Plans, showing in detail the original Boundaries of the same Counties, Baronies, Parishes, Townlands, or other Denominations, as laid down in Maps, together with the Boundaries proposed to be substituted therefor.

And whereas, no appeals having been taken to the definition and marking out of Boundaries so defined and marked out as aforesaid, the said Sir Richard Griffith, as such Boundary Surveyor, duly submitted to the Grand Jury of the said County of Down for approval, a Report setting forth in detail the proposed alterations in such Boundaries, with the grounds for making the same, accompanied by a Map, showing the Boundary or Boundaries as originally laid down on the Ordnance Plans of such County or other Denominations, and which said Report was approved of by the Grand Jury of said County of Down, and filed by the presiding Judge of Assize, at an Assize holden at Downpatrick, in and for said County of Down, at the Spring Assizes for the year 1858, and again at the Spring Assizes for the year 1859; and a like Report, accompanied by a Map as aforesaid, was submitted to the Grand Jury of each of the adjoining Counties of Antrim and Armagh, which said Reports were also respectively approved of by the Grand Jury of each of said Counties of Antrim and Armagh; and the same Report and Maps, after such approval as last aforesaid, were filed by the presiding Judge of Assize at an Assizes holden at Belfast, in and for said County of Antrim, at the Spring Assizes for the year 1858; and the same Report and Maps, after such approval as last aforesaid, were also filed by the presiding Judge of Assize, at an Assizes holden at Armagh, in and for said County of Armagh, at the Spring Assizes of the year 1859.

And whereas the said Sir Richard Griffith, as such Boundary Surveyor as aforesaid, with all convenient speed, after such alterations had been filed by the said Judges of Assize for the said Counties of Down, Antrim, and Armagh, respectively, prepared and made out a Report in detail of the proposed alterations in the said Boundaries, with the grounds for making such alterations, accompanied by a Plan or Plans showing in detail the original Boundaries as laid down on the Ordnance Plans, and which for easy reference be coloured *Red*, and said Plan or Plans, also showing in detail the Boundaries proposed to be substituted, and which proposed substituted Boundaries be coloured *Blue* on said Ordnance Plans, and hath submitted the same to the Lord Lieutenant

and Privy Council; and said Report and Plans are herunto annexed.

Now We, George William Frederick, Earl of Carlisle, Lord Lieutenant-General and General Governor of Ireland, and Privy Council of Ireland, in pursuance of the powers vested in Us for that purpose, do hereby make, order, and direct, that the New Boundaries so marked out by the said Sir Richard Griffith, as such Boundary Surveyor as aforesaid, and which are specified in his said Report so submitted to Us as aforesaid, and which are also marked out and coloured in the said Plans also submitted to Us as aforesaid, showing in detail the original Boundaries as laid down on the Ordnance Plans, and those which it is proposed to substitute for them, and which said Report and Plans as aforesaid are annexed as Schedules to, and are part of this Order, shall for all public purposes be, and be deemed and taken to be, the Boundaries of the said County of Down, and of the adjoining Counties of Antrim and Armagh, and also be deemed and taken to be the Boundaries of the several Baronies, Parishes, Townlands, and other Denominations of Land in the said County of Down, as specified in the said Report and Plans.

And We do further Order, Fix, and Declare, that this our Order shall take effect from the First day of November, in this present year, 1860.

And We do hereby further Order and Direct that the Order herein made shall not take effect, so far as relates to the Elective Franchise of any individual or his right to Vote at Elections of Members to serve in Parliament, at present enjoyed under any subsisting registry of such right, until the expiration of such subsisting registry; and that so far as relates to the Assessment, Applotment, or Collection of Grand Jury Cess, and the Presentment of Public Money, and any Grand Jury Presentment, and any matter and thing relating thereto, and the appointment of High Constables, and the Collectors of Public Money, this Order shall be in force and take effect from and after the next Spring Assizes to be holden in and for the said County of Down, County of Antrim, and County of Armagh, respectively; but that as to all new Registrations of the right of Voting at Elections for Members to serve in Parliament for the said respective Counties of Down, Antrim, and Armagh, and as to all Causes and Matters, Civil and Criminal, except those now pending in any of the Superior Courts, or Courts of Quarter Sessions, or Civil Bill Courts, and as to the Jurisdiction, Civil as well as Criminal, of any Justice of the Peace, Assistant Barrister, or Chairman of Quarter Sessions, or other person in and for the said Counties respectively, and as to all other intents and purposes whatsoever, not herein specially provided for, this Order shall commence and take effect from the said First day of November, 1860.

And We do further Order and Direct that this Our Order, and the said Report in detail, and the said Ordnance Plans, submitted by the Boundary Surveyor, shall remain on record in the Council Office, Dublin Castle, and shall be exhibited to any person or persons who may desire to inspect the same without fee or reward.

And We do further Order and Direct that a Copy of this Our Order, and of said Report and Plans, certified under the hand of the Clerk of the Privy

Council, shall be transmitted to the Clerk of the Peace of the County of Down, and that a further Copy of this Our Order, and of said Report and Plans aforesaid, certified as aforesaid, shall be also transmitted to the Clerk of the Peace of the County of Antrim, and that a further Copy of this Our Order, and of said Report and Plans, shall be also transmitted to the Clerk of the Peace of the County of Armagh, to be by such Clerk of the Peace respectively kept and preserved in his Office, as provided by the said Act of the 17th of Her Majesty's Reign, cap. 17, and by the said Act of the 22nd and 23rd of Her Majesty's Reign, cap. 8, to be by such Clerks of the Peace respectively kept and preserved in their Offices respectively, and exhibited at all reasonable hours to any person or persons who may desire to inspect the same without fee or reward.

And We do further Order and Direct that this Our Order, omitting the said Schedules, shall be published in the *Dublin Gazette*.
