

# How to Register as a Supplier on e-tenders.ie

\*\*NOTE: When registering as a Supplier on the eTender system it may at first sight appear that you have to be a registered company to do so. This, however, is not the case. The Law Reform Commission invites applications from companies, sole traders, academics, researchers or anyone who can demonstrate expertise in one or more of the categories.\*\*

To participate in calls to tender with the Office of Government Procurement you must first register yourself or your business as a supplier. If you have never previously registered as a supplier, then go to the homepage <u>https://etenders.gov.ie</u> and click on 'Register yourself and your organisation as a Supplier on the system' (circled below). This will bring you to the first step of the registration process.

On the next page you will register the CPV codes, or the tender areas that you are interested in. To find the relevant code click on the magnifying glass to the right of the screen (circled below)

This will bring you to a search screen where you can search for relevant CPV codes. Enter in the code number in the search box on the top left of the screen and click on the search button. Results will appear in the search results box below. Click on the code relevant to you and then click on the 'Add to list' button. The selected code should appear in the selected items box at the bottom. Once you have selected all of the codes you want click on the Submit button.

Once you click submit you will be brought to the next page where you will be asked to register an administrator. If you are just registering for yourself you can reenter your details in the web form, again you only have to fill in the boxes marked with a red asterix. You will be asked to create a password, make sure that you look at the password rules before doing this to make sure that your password is compliant.
